## **POWER TEST REPORTING INSTRUCTIONS**

### **BA 25-02**

The Suburban Law Enforcement Academy will administer the P.O.W.E.R. Test on Tuesday, April 22, 2025, at College of DuPage. Recruit officer candidates must report no later than 0715 hours to The Homeland Security Education Center (HEC) inside the hallway near Door 1. The College of DuPage map is provided for your convenience. Park in the lot immediately west of the HEC Building (Lot E)

Certified instructors will administer the test according to guidelines set forth by the Illinois Law Enforcement Training and Standards Board. Please dress for the weather. The run will be held on the College of DuPage outside track. Should your recruit officer candidate fail any part of the test, a re-test will be scheduled by the SLEA staff. Recruits will be instructed to contact their respective agencies for authorization to participate in the re-test.

We have included, on the web site, Medical Examination Package forms and a Medical Certificate which must be signed by a physician within 60 days prior to testing. All forms are emailed to the administration office prior to the P.O.W.E.R. Test so Recruit officers are not required to bring the certificate with them on the day of the test. **UNDER NO CIRCUMSTANCES** will a recruit be allowed to participate in the testing process without a signed certificate. A driver's license or some type of government issued photo identification will also be required for registration. A copy of the State P.O.W.E.R. Test Guide provides an outline of the test guidelines and administration protocols.

### **PLEASE NOTE:**

The Illinois Law Enforcement Training and Standards Board requires a Form E be electronically submitted by the employing agency 2 weeks before the recruit class begins. SLEA requires a copy of the Form E for the recruits file. Recruits need to have their PTB number from the ILETSB the first day of class.

Additionally, all other recruit registration paperwork and forms need to be submitted for seat confirmation prior to the date of the P.O.W.E.R. Test. All forms should be emailed to SLEA administrative staff. Recruit's will receive information on downloading the Recruit Guide after successfully completing the P.O.W.E.R. Test.

Recruits will be required to wear appropriate athletic attire for the test. A good pair of running shoes is recommended.

If the recruit does not meet all of the standards, they may be given another opportunity to fulfill the standards no sooner than 48 hours later.

There is a short orientation after the P.O.W.E.R Test, they should expect to be at the P.O.W.E.R Test until noon.

Please remind your recruit that they are representing your agency, dress and act appropriately. The law enforcement profession demands professionalism, no inappropriate attire, no ripped clothing, no hats indoors. They should not show up looking like they just rolled out of bed. Remind them they will be making first impressions at the P.O.W.E.R. Test.
