

# Illinois Board of Higher Education / Illinois Community College Board Task Force on Campus Sexual Misconduct Climate Surveys Spring 2025

Each higher education institution in Illinois is required by Illinois law (IL ILCS 155/35) to conduct an annual sexual misconduct climate survey of all students, beginning in Spring 2024. The survey will be developed by a Task Force and provided to College of DuPage by the Illinois Community College Board. The purpose of the survey is to gather information about the behaviors and perceptions that current students have related to relationships, sexual experiences, experiences with dating violence, and perceptions about safety at their college or university during the prior 12 months.

The College of DuPage Office of Research and Analytics emailed 19,698 students on February 25, 2025 and provided an anonymous link to the online survey form. A total of 367 students (2%) completed the survey form before it closed on April 30, 2025.

- All full-time and part-time students who were at least 18 years or older (as of February 25, 2025) were invited to respond to the survey. High school students taking dual-credit courses were not included.
- In addition to the email invitation, a link to the survey was included in student email newsletters (ChapNews) on March 5 and March 19. Information about the survey and a QR code directing students to the link was shared by the Title IX coordinator at sexual assault awareness month events in April.

Based on guidance from the state of Illinois, to protect students, response options with fewer than 20 responses are identified with "too few responses" for reporting.
